- The Greenhouse Gas Emissions with Taiwan Cooperative Financial Holding Co., Ltd. for the period from 2022-01-01 to 2022-12-31 was verified, including direct greenhouse gas emissions 35.692 tonnes of CO2 equivalent and indirect greenhouse gas emissions from imported energy emissions 120.237 tonnes of CO2 equivalent.
- No material misstatements for the period from 2022-01-01 to 2022-12-31 Greenhouse Gas Emissions calculation were revealed.
